Terms & Conditions

1. Annual subscription both for Klub & Golf membership for first year is Rs. 30,000/- per annum, payable in advance. The subscription for subsequent years will be payable in advance each year or as decided by the management from time to time. The rate of subscription is at the discretion of the management. The members joining during the year are charged subscription for the first year on a pro-rata basis from the month of joining till the forthcoming 31st of March except for members joining for the tenure of 1 year.
2. The dependent fee upto 18 years is part of the membership plan.
3. Usage of facilities such as tennis courts, squash courts, badminton, kids playing area, pool table, table tennis, fitness centre & swimming pool are inclusive both in Klub and Golf membership plans. Hot pool and Jacuzzi are not part of any membership plans and access will be as per the operating policies decided by the Club Management. Golf memberships apply to green fees only. Caddy and Cart fees are extra.
4. All group sessions/ classes and group training in the fitness centre is included in the membership plans. However, this does not include any Private Training (PT) package which a member may choose and will be charged as applicable. Any private lessons/coaching, workshops, clinics, etc. pertaining to tennis, squash, Kids playing area and swimming will be charged extra as applicable.
5. All applicants for membership will go through a screening process. The Management reserves the right to admit or refuse admission to any applicant and its decision in this regard shall be final and binding. In the event an application is rejected the entire membership fee paid by the applicant shall be refunded without interest. The registration fee of Rs. 1,000/- is non-refundable.
6. The approval of membership will be communicated through email/telephone. Once membership is approved by the screening committee, the applicant will be allotted a membership number and issued a membership card and the membership will commence from the date of issue of membership card. The members may use the facilities after issue of membership card only.
7. In case of termination of membership, the refund of the membership fee will be according to the refund schedule given in the rules and regulations.

8. All the applicable taxes are over and above and in addition to the membership fee and subscription shall be payable by the applicant.

9. Membership is governed by the rules and regulations of the club as amended from time to time.
10. Golf membership is available for only one member per family. It includes all facilities in the Klub for the entire family. If additional members of the family want golf membership, an extra membership charge of Rs. 75000 per player per annum will apply. Family includes – Member, Spouse and children below 18 years.
11. Duplicate Cards: In case of loss of card, a nominal fee of Rs.500/- shall be charged for issuance of a duplicate.

12. **Guest Policy:**

All guests have to be registered at the reception along with payment of Guest fees.

Guest Fees includes access to Sports facilities (Tennis, Badminton, Squash, Table tennis, Swimming Pool)

Guest Charges for a day @ Rs.500/- for Members.

Guest Charge for a day @ Rs.100/- per head for children under age of 12

In case a member enrolled in Klub membership wants to play golf, Green fees as applicable will be charged.

Guest fee of Rs. 100/- per head will be charged for Dining facility at Restaurants when accompanied with Member.
